- 2 drinks only per person at any given time
- Stops at 11:30 PM every night

ABC Forms & Health Permits:

- We will sign forms for you the week of July 11th July 15th between 10 am and 2pm only please bring your completed ABC form to the office where we will sign and include our letter
- Then that goes to CHP for them to verify, then to ABC, then back to CHP and finally a copy should be emailed to us at office@yolocountyfair.net
- You will also need to contact the health department and do all necessary forms and permits with them this can be done as early as now but no later than 30 days prior to the event.

Credentials & Passes:

- There will not be any on interior grounds parking for cars, trucks, or atvs

 however we will have a pass for the money person, and we will give
 them as close of access as we can to your booth while not being on the
 interior grounds.
- Credentials each booth will receive 50 credentials which will allow your servers to go through the credential lines in designated areas, so they do not have to wait in the main entrance lines.
- One day parking passes each booth will receive 50 one day parking passes as well so that those servers do not have to pay the parking fee

Other Items:

- Our 4 ticket places have gone out of business since 2019. We have no one that does custom printing and the one we found that does do it only has white ticket stock. So, with that we are going to allow you to use either new generic tickets in your booth colors or old tickets you have saved up. But it will be your organizations responsibility to get those. Alcohol Concessions - Terms and Conditions

Organization Name:	The Rotary Clubs of Yolo County

- 1. All person purchasing beer tickets will have their age verified with a valid government issued ID and have a wristband placed.
- 2. Alcoholic beverages shall be dispensed in clear plastic cups only.
- 3. Any bottled and canned drinks must be poured into a clear plastic cup.
- 4. Alcoholic beverage cups shall be identifiable from non-alcoholic cups.
- 5. Alcoholic beverage cups shall not be larger than 14 oz in size.
- 6. Only two (2) alcoholic beverage cups shall be dispensed per person at one time.
- 7. No hawking of tickets and alcoholic beverages. All sales of alcoholic beverages shall be from a fixed concession stand.
- 8. Volunteers / employees are prohibited from consuming alcoholic beverages while working or while in the vicinity of their organizational booth
- 9. Person(s) selling tickets, accepting money shall be eighteen (18) years of age or older.
- 10. Person(s) dispensing alcoholic beverages shall be twenty-one (21) years of age or older.
- 11. Sales of alcoholic beverages to end at 11:00 p.m. each night of fair and the serving of alcoholic beverages to end at 11:30 p.m. on each night of fair
- 12. At any time, a peace officer may order the sales of alcoholic beverages authorized under this license to cease immediately if an infraction has occurred to violate these terms of conditions and or your ABC License.
